

## **Alcohol Policy**

Preamble	• Mill Park Secondary College has a responsibility to fully inform our students, staff and whole school community about the effects of alcohol.
Aims	• Alcohol education forms part of our school's Drug Education Program and ensures that all students are made aware of the dangers regarding the effects of alcohol on the body and mind.
	• To ensure that a fair and reasonable process for responding to incidents involving alcohol is developed, understood and consistently followed.
Implementation	<ul> <li>Alcohol education activities will be included as part of our school's Drug Education program.</li> </ul>
	• Where appropriate, our school will access agencies within our local community with expertise in the field of alcohol education to participate in our programs, e.g. local police, Community Health Service, Brainstorm Theatre Productions, Drug & Alcohol counsellors.
	• Any lesson content related to alcohol will be delivered within the context of a harm minimisation approach to drug education.
	• Clear protocols will be followed for addressing the issue of a student, staff member or community member attending school or a school function under the influence of alcohol.
	• Students are not permitted to bring or consume alcohol on school grounds, travelling to or from school or school camps/excursions under any circumstances.
	• Where there are reasonable grounds for suspicion of alcohol use or possession, a Principal Class officer or designated officer may, in the presence of the student and another teacher, search property such as a bag or a locker (which is deemed to be the school's property) and can seize any alcohol as per DET 'Banning, Searching and Seizing Harmful Items Guidelines'. Students can be instructed to open pockets or bags for inspection and failure to comply may involve the school contacting Victoria Police.
	<ul> <li>If a student is suspected of having consumed alcohol or is intoxicated, parents/carers will be notified immediately and the student will be sent home. See <u>specific responses</u> below.</li> </ul>
	• During camps or excursions, staff will act in accordance with their duty of care to students, which is in force during the entire time of a camp or excursion.
	• Staff will be aware that consumption of alcohol by them during camps or excursions is:
	<ul> <li>inconsistent with the standard of professional conduct necessary to maintain community confidence in these activities</li> <li>is considered unwise</li> </ul>
	- could lead to allegations of negligence and loss of WorkCover rights.
	SPECIFIC RESPONSES
	• Students found drinking, in possession of alcohol, buying alcohol from other students or supplying alcohol to other students or as a bystander in their company, will be liable to a range of consequences dependent on the circumstances and whether or not previous offences have been recorded, at the discretion of the Principal.

	<ul> <li>Incident report recorded</li> <li>Parent/Carer notified via phone call and formal letter</li> <li>Student sent home from any external activity at parent/carer expense</li> <li>Suspension from school</li> <li>Referral to Student Welfare Coordinator for sourcelling strategies in horm minimization</li> </ul>

• Referral to Student Welfare Coordinator for counselling strategies in harm minimisation
