College Principal's Report

Welcome back to school everyone! I am so pleased that the year has begun smoothly and that the past two weeks of classes has seen our students across the College engaged and focused on their learning. In particular I would like to welcome our new Year 7 students and their families, and any other students who may be new to the College at other year levels.

Having only recently arrived at Mill Park Secondary College mid-2021 myself, I understand that making the transition to a new school setting can be daunting, however, it is great to see the positive way that our Year 7 cohort has commenced the year. In classes as well as our in the yard I have spoken with students who are calm, happy and confident about this transition that they have begun. The Middle School team is committed to ensuring that this positive approach continues. I look forward to seeing many of our new families at the upcoming Year 7 Welcome Picnic on Monday 14 February at 5pm, Middle Years Campus.

At the other end of the school it is excellent to see the way that our Senior students have returned to school. For many of our Year 10 students they will be undertaking new curriculum and possibly VCE and VET subjects in a new environment. For our Year 12 students, after completing two weeks of Headstart in December 2021, they are already well into their programs. Of course not all students will have settled in as easily and I encourage you to make contact with us if you feel that your young person has not settled into a good routine of attendance at school and a healthy balance between rest and recreation, and revision and study at home. This is especially important for our Senior students as the pressures they face and demands on their time increases.

Across the course of 2022, we will be focused on building the strongest partnership between home and school that we can. This is different to the idea of 'remote learning' that we have had to face together over the past two years - we hope we don't have to go back to this! Instead we want you as parents and carers to have a clear understanding of what our priorities are here at school, how students are progressing, and importantly how you can reinforce and support their learning and wellbeing. There will be opportunities to engage with the school through forums across the course of this year and I look forward to welcoming you to these events.

Coming in to the new school year the situation regarding COVID-19 has created a level of uncertainty about exactly how things would play out. Whilst it is early days I am glad to say that the impact of positive cases is limited at present to small numbers of staff and students, and we are able to manage the disruption. I thank everyone for helping us keep the school community safe through supporting the twice-weekly Rapid Antigen Testing program. Please continue to do this and contact us here at school if you have any questions. I have also shared information regarding vaccination and also the program for third dose or 'booster' shots, for which many of our students will now be eligible. If you have not already, I encourage you to consider this important step against COVID-19.

After being at Mill Park Secondary College for the second half of 2021 in the Acting Principal role, I feel that I have had a good induction into the school. I am looking forward to working closely with our school community over the coming weeks and months to ensure that we can do whatever we can to support all of the young people at the College. I encourage you to make contact with me or the school at any stage to provide us with any feedback or ideas that you feel will help assist us in this endeavour.

MY Campus Principal's Report

It has been a very positive start to the term, with students from all year levels engaging well with their learning during the first two weeks. This is a testament to students' stamina and an acknowledgement of their effort to stay focused. It has been encouraging to see students interacting positively with their teachers, classmates and peers. This sort of connection is a crucial element in supporting students to continue growing (academically, socially and emotionally). We hope this focus on positive relationships contributes to high levels of respect across the campus.

Melissa Stephens (Assistant Principal) and I had the chance to speak with all students throughout the first week, to emphasize how happy we are to see them and how much we are looking forward to being at school for the whole year. We were also able to clarify expectations and are really pleased with how students are meeting them in all these areas:

COVID-19 safe behaviors

Classroom engagement and effort Attendance and punctuality

Phones (& Air pods)

Uniform

There was overwhelming appreciation from our students, with respect to greater flexibility in the choice of uniform items. We appreciate how readily students have met the expectation that they must wear uniform, and are proud of how they look around the school and out in our wider community. If there is a situation where your child cannot wear uniform, please have them choose appropriate items to wear and provide them with a note. **Hoodies** and **leggings** will not be accepted as replacement items, so prompt students to choose again, if they mistakenly select these items.

Where students attend without uniform, a note or inappropriate items, they will be given the following options:

Remove the non-uniform items

Replace the non-uniform items with uniform provided by the school
 Call home to arrange for uniform to be brought to school
 With your support at home, we are confident students will continue to make positive choices, work within these expectations and represent our school with pride via their appearance.

Students also worked briefly on the school environment during a quick 10 minute clean up this week. The students' contribution made a big difference to the grounds, and we appreciate and acknowledge their efforts. To give context to this clean up, we explained to students that how we look after our environment impacts on us all. If we have an untidy school, we tend to undervalue ourselves, our school and the things we do. For that reason, our positive expectations are:

Individuals should put their rubbish in the bin We should respectfully remind others to put rubbish in the bin - if they have missed this step We should take collective responsibility for cleaning up rubbish - even if it is not our own If asked by a staff member - students are expected to manage rubbish as requested

"We don't walk past rubbish at Mill Park, we pick it up and put it in a bin". We will have regular short clean -up sessions, as we work toward making this our daily practice.

We are also thrilled that all student activity consent will be completed through the Sentral Parent Portal. This is most easily accessed via the "Sentral for parents" app, available from app stores for all smart phones. You can also access the online version of Sentral through the quick links on our website, if you have not already created a link for yourself.

This feature will save considerable time for staff, students and families, through elimination of the need to create, source, find, sign and return permission forms. Our ecological footprint will also be reduced as a positive consequence of this change.

Each activity will have a set deadline. It is important to meet these deadlines, as past experience has taught us that making last minute changes to attendance puts undue pressure on a range of people and can create unacceptable risks for participants. For this reason, consent for participation in activities will not be accepted beyond set deadlines.

To support ease of payment for camps, sports and excursions or any other voluntary contributions, we prefer families use the Qkr app, which also provides you with itemized accounts for required payments. If your family is eligible for the Camps, Sports and Excursions Funding (CSEF), just phone or email the school to indicate your preference to use this, for eligible activities.

This has contributed to the timely filling of places for the Year 7 Camp and the ability to quickly get our first MYC sports team out and competing- Yr.9 Boys Cricket, who finished third against some strong opposition.

We are looking forward to greeting our Year 7 families at the Welcome Picnic on Monday 14 February, but more so to what I'm sure will be a positive, full year of school, with only the occasional 7-day interruption. Keep in mind our partnership with you, as supportive families and feel free to reach-out with any questions, so we can work together to create the best opportunities for all of our students.

CSEF ELIGIBILITY

Below are the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

Criteria 1 - General eligibility

To be eligible for the fund, a parent or carer of a student attending a registered Government or non-government Victorian primary or secondary school must:

- · on the first day of Term one
- · on the first day of Term two
- a) be a holder of one or more of the eligible financially-means tested cards **OR** be a temporary foster parent, and:
- b) submit an application to the school by the due date.

For the list of eligible financially-means tested cards refer to the CSEF Policy: https://www2.education.vic.gov.au/pal/camps-sports-and-excursions-fund/policy

Parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with the above.

Criteria 2 - Be of school age and attend school in Victoria

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. CSEF is not payable to students attending pre-school, kindergarten, home schooled, or TAFE.

Special Consideration

A special consideration category exists for

- Families on a bridging visa, temporary protection visa, in community detention or are asylum seeker families
- Students in temporary out of home care arrangements, including statutory kinship care

Eligibility Date

For concession card holders CSEF eligibility will be subject to the parent/carer concession card being validated successfully with Centrelink on the first day of either term one (31 January 2022) or term two (26 April 2022).

PAYMENT AMOUNTS

CSEF payment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- Primary school student rate: \$125 per year.
- Secondary school student rate: \$225 per year.

The CSEF is paid directly to your child's school and will be allocated by the school towards camps, sports and/or excursion costs for your child.

For ungraded students, the rate payable is determined by the student's date of birth. For more information, see: www.education.vic.gov.au/about/programs/Pages/csef.aspx

Year 7 government school students who are CSEF recipients are also eligible for a uniform voucher. Secondary schools are required to make applications on behalf of parents/carers so please register your interest at the school.

HOW TO COMPLETE THE APPLICATION FORM

NOTE: ALL SECTIONS MUST BE COMPLETED BY PARENT/LEGAL GUARDIAN

- Complete the PARENT/CARER DETAILS section.
 - Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.
 - If you are claiming as a temporary Foster Parent or a Veteran Affairs Pensioner, you will need to provide a copy of documentation confirming your status as a temporary Foster Parent or provide your Veterans Affairs Pensioner Gold card to the school.
 - If you are seeking special consideration, mark this in the form and provide a copy of the relevant documentation.
- 2. Complete the STUDENT/S DETAILS section for students at this school.
- 3. Sign and date the form and return it to the school office as soon as possible. The CSEF program for 2022 closes on the 24 June 2022.


Look out for the reduced speed limit around schools and slow down to improve safety.

No parking on nature strips/footpaths




Parking is illegal on nature strips and footpaths.




- Look out for flags and Crossing Supervisors
- You must stop for anyone waiting to cross, or who has started crossing
- Please remain stopped until the crossing is clear.

Within 10 metres of an intersection



A driver must not stop with any part of their vehicle within 10 metres of an intersection unless signed otherwise.

Stopping across driveways



It is illegal to, stop/park across a driveway unless you stay in the car are there for no more than two minutes and move immediately if required to do so to allow entry or exit by the owner/occupier.

Parking/Stopping signage









No stopping areas must be kept clear. If times/days are specified, restrictions are only applicable to the specified times/days. You cannot park in a P3 minute area for longer than three minutes.

Double parking



It is illegal to double park at any time. This affects the flow of traffic.

3 metre gap for signage



At least 3 metres must be left between your vehicle and the centre dividing line to allow other vehicles to pass safely and not obstruct traffic.

What can you do to stay safe

- Supervise your children in or near traffic
- · Walk or cycle to school with your child
- Respect all road rules, parking signs and instructions from authorities
- Wait on the same side of the street as your child
- Always let your child out of the kerb side of the car.
